**I. Call to order**

The meeting was called to order around 7:57 pm.

The TAB had a brief round of introductions for the two newly appointed members and the guest (Flora) who is also an applicant.

**II. Approval of Minutes (February 6, 2020)**

Motion made by Alexander to approve the minutes, seconded by Pcolar. Motion passed unanimously.

**III. Action & Discussion Items**

• **Discussion of Proposed LUO Text Amendment for the RR-MU Zoning District**

The TAB discussed the implications that the proposed text amendment, if applied through a rezoning, could result in displacement of existing residents or households. The

TAB also discussed the preferences for mixed use types of development, the history of the Rogers Road Area, the Greene Tract, the Community First model, the coordination of land use planning which may occur with Chapel Hill.

The TAB discussed the benefits of the mixed use district to enable short local trips to access necessary services within the neighborhood rather than have no option other than to use cars for external trips.

TAB discussed the infrastructure needs along Rogers Road including sidewalks, bike lanes, impacts of traffic, public transportation along the corridor and the need to partner with NCDOT for necessary safety improvements

Zach provided information about infrastructure and transportation projects that affect Rogers Road.

A motion recommending that the Town Council approve the draft LUO amendment was made by Pcolar and seconded by Keefe. The motion passed four (Pcolar, Swan, Keefe, and Brown) to one (Alexander).

A unanimous show of hands from the TAB indicated no financial interest in this project.

A motion indicating that the TAB finds the proposed LUO amendment consistent with adopted Town of Carrboro Plans and Policies was made by Pcolar and seconded by Keefe. The motion passed four (Pcolar, Swan, Keefe, and Brown) to one (Alexander).

- **Discussion of Open Streets 2020**

Swan asked if there was a contingency plan in place for the Coronavirus. Zach responded that the Town had not yet discussed what would change.

TAB discussed potential options for open streets including the one-way pairing of E Weaver/E Main, turning E Weaver into a pedestrian mall, asking residents where they wanted sidewalks.

The TAB discussed safe routes to school vs green routes to school and how they could emphasize the green aspects of Safe Routes to School and other air quality programs such as the air quality sign at Carrboro Elementary and how these programs can help change social norms.

#### **IV. Staff News Items & Other Discussion**

Zach provided the following updates:




